

## **MBA Player Contract**

EMERGENCY AUTHORIZATION: I, the signing parent or legal guardian of the player, a minor, hereby authorize the coaches, team parents, the named Emergency Contact and/or Montebello Baseball Official to act as my agents in the Capacity of activity supervisors and vehicle drivers, and to consent to medical, surgical or dental examination and/or treatment.

DISCLAIMER, ASSUMPTION OF RISK AND WAIVER: I, the signing parent or legal guardian of the player, a minor, for myself and on behalf of the named player, our heirs, assigns and next of kin, acknowledge that participation in baseball necessarily involves play in adverse field conditions, contact with considerable force, and risk of severe, permanent physical injury including bruises, scrapes, strained, sprained and torn muscles, tendons or ligaments, broken bones, dislocation of joints, concussions, brain damage, nerve and spinal cord injury, paralysis and death. For myself, and on behalf of the named player, our heirs, assigns and next of kin, we willingly and accept and assume all such risks.

The insurance MBA provides, is strictly a secondary insurance policy. If you are in need of a primary insurance policy, please inform MBA in writing.

VOLUNTEERS: For myself and on behalf of the named player, I further acknowledge that Montebello Baseball Association is primarily made up of volunteers rather than paid professionals. For myself and on behalf of the named player, he/she and I willingly and voluntarily agree to comply with the stated and customary terms and conditions for participation and, if he/she or I observe any unusual significant concern in his/her readiness for participation and/or in the program itself, I will remove him/her from

participation and bring such concern to the attention of the nearest official immediately.

In consideration of accepting the registration and permitting the voluntary participation of the named participant in its programs, for myself and on behalf of the named player, our heirs, assigns and next of kin, I hereby release, discharge and agree to hold harmless, its volunteers, officials, sponsors and other representative and any and all owners, lessors, lessees or other persons or entities allowing, permitting or authorizing the use of facilities by MBA and the agents, officers and directors of said persons or entities from any and all claims, demands, costs expenses and compensation arising out of or in any way related to any injury or other damage that may result to said participant or participating in or present at any MBA-sponsored event, including any physical or other injury caused by the negligence of any person or entity described above.

**ACKNOWLEDGMENT AND CONSENT:** For both internal and external use, I acknowledge that MBA may compile and use addresses and baseball photographs of the named individual. I consent to such uses and hereby waive all rights to compensation.

**REFUND POLICY:** A player is deemed to be on a team, once the player is drafted. The draft will occur approximately three weeks before Opening Day Ceremonies. It will be the Parents/Guardians, of named player, responsibility to submit a request in writing to have a player removed from the league. Refund will be given minus \$50 Deposit. All refunds will be forfeited once a player has been placed on a team and a uniform has been ordered.
